## RESOLUTION TO AUTHORIZE REVIEW OF AN EDUCATOR PREPARATION PROGRAM Birmingham-Southern College

WHEREAS, Alabama Administrative Code, Rule No. 290-3-3-.59(4)(b)2, requires that approval by the Alabama State Board of Education shall be secured before a proposal for a new program is reviewed by the Office of Teaching and Leading of the Alabama State Department of Education; and

WHEREAS, the State Superintendent of Education has received from the President of Birmingham-Southern College a written request to develop a Class B English Language Arts (6-12) program; and

WHEREAS, the request lists the specific proposed program for which the Alabama State Board of Education approval is being sought, together with information concerning the factors to be considered in determining the need for the program; and

WHEREAS, Birmingham-Southern College was approved to prepare teachers of English Language Arts, but decided not to continue the program because no students were enrolled; and

WHEREAS, current Birmingham-Southern College students have expressed an interest in preparing to teach English Language Arts; and

**WHEREAS**, Birmingham-Southern College personnel wish to provide more teachers to help address the acute shortage certified applicants; and

WHEREAS, Birmingham-Southern College personnel have been advised that the proposed program may not be implemented prior to Alabama State Board of Education approval, based on documentation of compliance with all applicable standards; and


WHEREAS, the State Superintendent of Education recommends that the program be reviewed by the Office of Teaching and Leading of the Alabama State Department of Education:

## Birmingham-Southern College Authorize Review of Class B English Language Arts (6-12) February 10, 2022

Birmingham-Sothern College prepared English Language Arts (ELA) teachers for many years, but decided to discontinue the program because students no longer chose to enroll in that program. Current students have expressed an interest in earning a certificate to teach English Language Arts. Birmingham-Southern College has requested permission to develop a Class B English Language Arts program for Grades 6-12 and is hoping to do so as soon as possible to help address the critical need for more certified ELA teachers.
