WHEREAS, early identification and intervention will equip many students with dyslexia for success in school and in life; and

WHEREAS, the Alabama State Board of Education has specifically addressed dyslexia within the *Alabama Administrative Code*; and

WHEREAS, the Alabama State Board of Education has committed itself to supporting Alabama schools and teachers with resources, materials, and professional development; and

WHEREAS, the Alabama State Board of Education has committed to the goal that every child will read on grade level:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education recognizes October 2022 as Dyslexia Awareness Month and encourages school systems to engage their schools, families, and communities in activities that create a culture of understanding, support, encouragement, and learning for students having dyslexia.

- **WHEREAS,** manufacturing employs over 12 million American directly, and many more indirectly in the U.S.; and
- **WHEREAS**, manufacturing companies employ 258,333 individuals in Alabama which signifies 13.53% percent of the workforce; and
- **WHEREAS**, our community's manufacturing companies are vitally important to the prosperity of the state of Alabama; and
- WHEREAS, on Manufacturing Month, we commit to strengthening and supporting the Alabama manufactures and hardworking manufacturing employees of today as well as the manufacturers and workers of the future; and

WHEREAS, the State Superintendent of Education recommends approval:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education does hereby proclaim October 1-31, 2022, as Manufacturing Month and encourages local boards of education, schools, business professionals, and local educational organizations to participate in this celebration through activities that demonstrate the importance of Alabama's education programs in preparing students for great career opportunities and academic excellence.

WHEREAS, the School Lunch Program served over 83,244,019 million lunch meals for the school year 2021-2022 to Alabama students:
